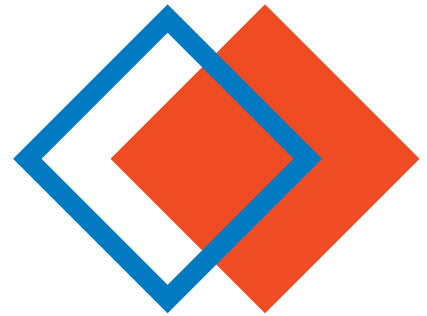
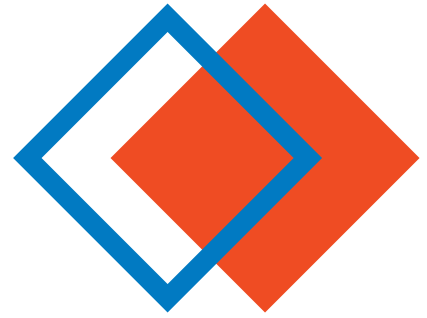
# OVERVIEW

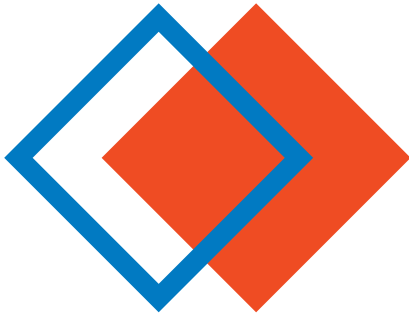

## 2024 Schedule

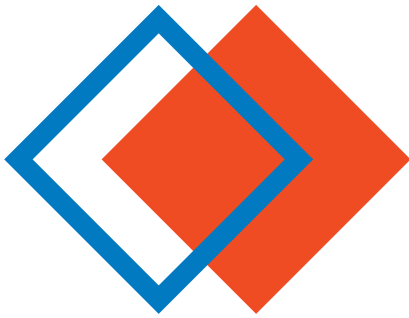

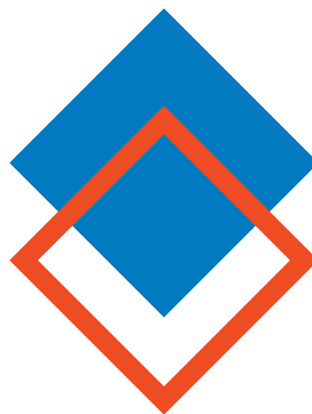

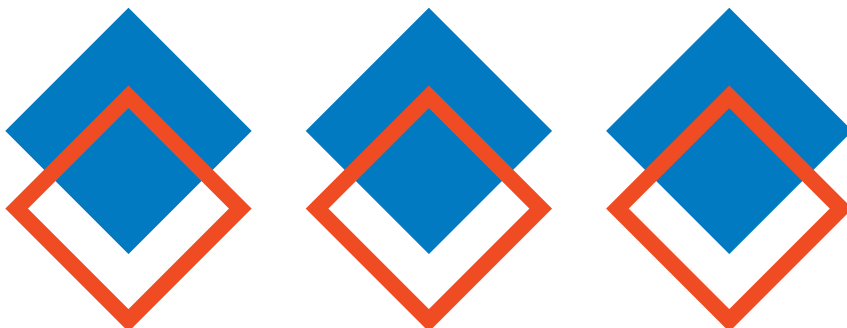
